Organizations of all types are under intensifying pressure to govern themselves more effectively, achieve high levels of performance, comply with regulatory requirements, and manage diverse risks — all of which add up to executives and board members being held more accountable. These converging factors have created an urgent imperative to improve and integrate GRC into core business processes and decision-making.

While the concepts of governance, risk, and compliance are often spoken of in the same breath, we have found the connections among them and how they relate to performance management are rarely leveraged efficiently and effectively. Governance is viewed as separate from mainstream business processes and information flows; risk management is based on siloed assessments and disconnected efforts within individual business units or functional areas; compliance often translates into a labyrinth of one-off approaches with redundant, manual controls and duplicative reporting on top of core business activities and decision-making. And, while performance management often receives focused attention, we have found that it is too often seen as completely unrelated to GRC.

Thursday's discussion will highlight a comprehensive approach to Governance Risk and Compliance enabling companies to effectively and efficiently comply with governance requirements by integrating existing and new components within your organization. Taking it one step further, we will discuss why IT should play a central role in GRC

The Certified Information Systems Auditor (CISA) is ISACA's cornerstone certification. Since 1978, the CISA certification has been renowned as the globally recognized achievement for those who control, monitor and assess an organization's information technology and business systems.



The Certified Information Security Manager (CISM) certification is a unique management-focused certification that has been earned by more than 13,000 professionals since its introduction in 2003. Unlike other security certifications, CISM is for the individual who manages, designs, oversees and assesses an enterprise's information security.



The Certified in the Governance of Enterprise IT (CGEIT) certification program was designed specifically for professionals charged with satisfying the IT governance needs of an enterprise. Introduced in 2007, the CGEIT designation is designed for professionals who manage, provide advisory and/or assurance services, and/or who otherwise support the governance of an enterprise's IT and wish to be recognized for their IT governance-related experience and knowledge.



The Certified in Risk and Information Systems Control™ (CRISC) certification is designed for IT professionals who have hands-on experience with risk identification, assessment, and evaluation; risk response; risk monitoring; IS control design and implementation; and IS control monitoring and maintenance. CRISC recognizes a wide range of professionals for their knowledge of enterprise risk and their ability to design, implement, monitor and maintain IS controls to mitigate such risk.

10,000 Earn the CRISC Certification

The newest certification from ISACA®, Certified in Risk and Information Systems Control™ (CRISC™), reached a milestone in the month of June when the 10,000th professional was certified. The opportunity to earn the certification under the rigorous grandfathering provision began 1 April 2010 and ended 30 June 2011, and more than 16,000 applications were received during that period. The grandfathering program allowed IT professionals who have significant experience with risk identification, assessment and evaluation; risk response; risk monitoring; information systems (IS) control design and implementation; and IS control monitoring and maintenance to earn the CRISC credential without taking the exam.

With the grandfathering period now closed, individuals wishing to become CRISC-certified are required to pass the CRISC exam, which will next be held on 10 December 2011. To learn more about this certification, including exam information, please visit the [CRISC](#) page of the ISACA web site.

COBIT 5 Public Exposure Extended to September Members Strongly Urged to Comment
